# Transition & Planning

Birth to  
Age 6

Livingston County Special Services Unit in partnership with local School Districts, Child & Family Connections, Birth to Three service providers and/or other agencies work together to assure an easy transition should a child be in need of specialized services to support success in the school environment.

When a child turns 30 months, with parent permission, the Child and Family Connections Service Coordinator calls a Transition Planning Meeting. The Parent, Coordinator, and Local School District Representative come together to discuss possible options for the child once they turn 3 years of age.

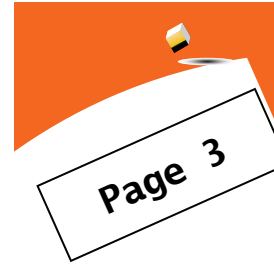
Between 2.6 years and 2.11 years the Early Learning Team (ELT) from a child's home district (see page 8) comes together to discuss the child's needs. Members of this Early Learning Team must include the Parent, School District Representative, and Assessment team member(s). It may also include Service Coordinator from Early Intervention, Program Supervisor, Therapists, Child Care provider, Pre-K and/or Early Childhood Special Education Teachers, and any other person necessary. After reviewing all gathered information, the ELT members may decide:

1. No services are needed at this time.
2. Information from the early intervention providers is adequate to make educational decisions.
3. Further evaluation is required to make decisions for the child's educational needs.

When evaluations (if needed) are completed and all relevant information is gathered, a decision for needed services is achieved by mutual respect and open communication between parents and professionals. Options for instruction may include:

1. Local district Pre-K (at-risk) program
2. Speech/Language Therapy
3. Occupational/Physical Therapy as a related service
4. Early Childhood Special Education
5. Dual enrollment in Pre-K, Early Childhood Special Education, Kindergarten, and/or Head Start

Services are provided in the least restrictive environment in the student's home school whenever possible. However, some students require very specialized and intensive instruction and, therefore, may attend programs in neighboring school districts or specialized schools.

ITEP serves children (birth to age 3) who reside in Livingston County and who are at-risk for developmental delays. Children must meet eligibility requirements: less than a 30% delay in one area of development (speech, language, cognitive, motor, or adaptive/social skills) OR at least one psychosocial, maternal or physical risk factor. Services may include: screenings, assessments, enrichment visits, enrichment groups, family education and support and case management.

OSF offers a Transition Playgroup for children 2½ to 3 years of age. This free playgroup meets on Monday from 9:00 - 11:00 a.m. and is designed to acquaint children with the structure of a school program before they enter school. Activities include group/circle time, music, snacks, arts and crafts.

**CCRRN** provides referrals to child care options in McLean, Dewitt, Ford, and Livingston Counties. Parents are counseled on how to select quality childcare that best meets the needs of their child. CCRRN provides training and education to child care providers and oversees a car seat loan program. Financial assistance is available to low-income families to assist in paying for child care. The Quality Counts van delivers resources and educational materials to child care providers. A Nurse Consultant is available for health related questions and training for child care program.

**CFC** is the central point through which families enter the Illinois Early Intervention Services System. This program is for children birth to three years of age who have developmental delays or a medical diagnosis. Referrals can be made by parents, nurses, grandparents, social workers, doctors, teachers, friends or any concerned individual. If a child is eligible for services, an Individual Family Service Plan (IFSP) meeting is held to develop a program to meet the child's needs. Services may include one or more of the following: developmental therapy, physical therapy, audiology, occupational therapy, assistive technology, transportation, speech/language therapy, nutrition services, medical diagnostic services, nursing services, service coordination, social work services and special instructions.

### Preschool for All programs (cont.)

The Creative Curriculum is used in these programs providing a scope and sequence of skill development for teachers to follow assisting children to be ready for Kindergarten. Children who are 3 to 5 years of age can be enrolled if they have participated in a developmental screening. If a child is age eligible for Kindergarten they may **not** be enrolled in a Preschool for All program.

The LCLIC advises and assists the CFC in the coordination of local people and resources necessary to implement a comprehensive service delivery system. Members include service providers, parents, local agency and school representatives. Meetings are held on a regular basis to identify and fill gaps in services and to develop strategies for public awareness, child find, provider recruitment and transition activities. The two major community activities the LCLIC sponsors are:

A free family activity is held in early June for children and their families who are receiving Special Education Services. Previous events have included: 1. A Picnic at the 4-H park with a free lunch, activities for the kids, and informational booths for the parents. 2. A Family Movie at a local theater with free soda and popcorn and goodie bags with educational toys and information from local agencies.

The Going, Giving, and Getting, the Extra Mile Conference is held in October each year. This free one day conference is for anyone living with or working with children Birth-6 years who have special needs. The GEM conference provides Speakers on current topics in education, health, family issues, etc. Informational booths and door prizes make the day informative and fun! Committee members come from various backgrounds such as teaching, nursing, child care, early intervention, etc. Each year a "theme" is carried out from costumes to decorations to break-out sessions. Almost everyone goes home with inspiration, information, and a door prize!

## Early Learning Teams/Leaders

Member school districts within LCSSU have Early Learning Teams. These teams may include Parents, early Childhood Teachers, Speech Therapists, Psychologists, Social Workers, Program Supervisors, Occupational and/or Physical therapists. This team participates in Preschool screenings and global assessments for children 2 1/2 through 5 years of age. Generally a Preschool teacher or an Early Childhood Special Education Teacher leads this team and coordinates their activities.

## Early Childhood Special Education Programs

If a child from 2 1/2 through 5 years of age has participated in a Comprehensive evaluation and the Early Learning Team has determined a significant delay exists, they may need the intensive, individual programming offered in an ECSE program. Each district offers this intensive programming either in their neighborhood schools or a cooperating district. An individual Education Plan is written for each student and reviewed at least on time per year.
